Email Scam Targeting Members

Dear Members,

We want to bring to your attention a recent scam targeting members of our organization. Fraudulent emails are being sent by individuals pretending to be officers or other prominent members within the VFW Auxiliary. These emails often request the purchase of gift cards or other forms of financial assistance on behalf of someone else.

Key Points to Keep in Mind:

- Be Wary of Unusual Requests: If you receive an email asking you to purchase gift cards or fulfill any unusual financial requests, exercise caution. This is a common tactic used by scammers.
- Verify Email Addresses: Recent scam emails have originated from illegitimate email addresses that use a prominent member's name but are not their actual email.
- For example, several members received emails from <u>foreignwarveteran@gmail.com</u> claiming to be National President Brenda Bryant. This is not her actual email address, but rather an impersonation.
- Be Vigilant Even with Familiar Addresses:

Although the recent scams have not involved hacking official email accounts, hacks of legitimate addresses are still possible. Always exercise caution when responding to emails, even from known contacts.

Scholarship recipients earn \$1,250 to use toward their education and related expenses. Applications are due to VFW Auxiliary National Headquarters by February 15, 2025.

Open to students in grades 9-12 by March 31, 2025 deadline. THE DEADLINE/

4 Both categories have the same rules:

- If the American Flag is used, you it must conform to the Federal Flag Code in relation to colors, number of stars and stripes and other pertinent rules of the code.
- Complete typed explanation of the entry (250 words or less) along with application with parent or guardian signature and include it with the entry.
- **4** Entry must be completed during the current school year

Two Dimensional: National Scholarships First place - \$15,000

Entry must be on canvas or paper, watercolor, pencil, pastel, charcoal, tempera, crayon, acrylic, pen, ink, oil, marker or other media may be used.

Entries may not be smaller than 8" x 10" and not larger than 18" x 24", **INCLUDING** mat.

*Digital art and photography are not accepted.

Three Dimensional: National Scholarships First place - \$2,500

- Entry may be paper, papier mâché, pottery, sculpture, fabric, wood, metalwork, etc.
- Entry may not be larger than 18" in any direction and may not weigh more than 5 pounds.

*Digital art, photography, weapons, art generated by a 3-D printer and jewelry are NOT accepted.



Article VII OFFICERS:
